- The panel notified Trainer Robert Doyle concerning a certificate of positive analysis for the class IV drug Dimethyl Sulfoxide (DMSO) on the horse "Reiki" from December 18th 2107 in race 1 at Western Fair Raceway. Mr. Doyle was in tonight to pick up his disclosure papers.
- Fourteen of the scratches this evening are due to the weather.
